Contest Guidelines

1. Organizer

3. Objectives

To promote the development of technological arts in Macao and inspire residents' enthusiasm for AI creativity, the Macao Government Tourism Office is organizing its first-ever AI Generative Art Contest. In celebration of Macao's designation as the "2025 East Asian City of Culture", this year's contest adopts the theme "Cultural Harmony · Fireworks in Bloom", inviting AI art enthusiasts in Macao to showcase the integration of "Tourism + Technology" by combining AI innovation with fireworks artistry.

4. Theme

Cultural Harmony · Fireworks in Bloom

5. Eligibility

AI creation enthusiasts aged 12 and above.

6. Contest Groups

Category	Age				
Youth Group	12 to 18 years old	Born in 2007 – 2013			
Open Group	19 years old or above	Born in or before 2006			

7. Entry Dimension

- 7.1 Format: JPG / PNG / TIFF, resolution \geq 300 dpi, max. 50 MB per file.
- 7.2 Works must be created using AI generation tools (e.g. MidJourney, Stable Diffusion) and retain the creation process record (e.g. drafts, parameter screenshots) for verification.
- 7.3 File naming: Group_Work Number_Work Title_Author's Name.jpg (Example: Youth Group_01_AI Colorful Fireworks Shine Over Macau_Chen Da Wen.jpg), works not complying with the naming convention will not be judged.







8. Number of Entries

Each participant may submit a maximum of 2 original works, which must not infringe upon any third-party rights.

9. Submission Dates

7 to 31 October, 2025 23:59 (Macao time).

10. Entry Form

11. Submission of Entry

Participants must enter the contest as individuals. Please email the contest form and works to info@aaam.org.mo by October 31, 2025. A confirmation reply will be sent by the coordinator upon receiving the submission. Complaints regarding lost submissions due to large attachment sizes will not be accepted.

12. Submission Contents

- 12.1 Completed entry form (Chinese name, Portuguese name, contact number, proof of age, etc.).
- 12.2 Work files (in accordance with the naming guidelines).
- 12.3 AI creation process record (screenshots or project files).

13. Number of Entries

Each participant may submit up to 2 works, which must be newly created in 2025 and not publicly published.

14. Judging Committee

- 14.1 The judging panel is composed of representatives from the Macao Government Tourism Office and professional experts.
- 14.2 If the entries fail to meet the award requirements after being reviewed, the prize may not be awarded.
- 14.3 The final decision made by the jury committee shall prevail, and no appeals will be entertained.

15. Assessment Criteria (each accounting for 25%)

- 15.1 Theme relevance: How clearly it conveys the fireworks display and the characteristics of Macao.
- 15.2 Visual expressiveness: Composition, color, and detail completion.
- 15.3 Technical innovation: Unique application of AI tools and creative presentation.
- 15.4 Artistic impact: Aesthetic value and emotional resonance of the work.







16. Announcement of Winners

- 18.2 The entrant shall agree to provide personal information which will only be used for the purposes of the event and will be processed in accordance with the provisions of the "Personal Data Protection Act" (Act No. 8/2005).
- 18.3 The entrant must accurately complete all information in the entry form. In case of any omissions or inaccuracies, the organizer reserves the right to disqualify the entrant.
- 18.4 The entrant must confirm their status as the original copyright owner of the work. In the event of infringement on the copyright, patent, or other rights of a third party, the organizer reserves the right to withdraw their eligibility and seek compensation. Participants are required to return any prizes, trophies, and certificates awarded, assuming full legal responsibilities.
- 18.5 The submitted entries must not contain any violent, obscene, pornographic, defamatory, morally questionable, insulting, controversial, or inappropriate content.

The Macao Government Tourism Office reserves the right to reproduce, publish, display, or use the photos, either in whole or in part, for promotional purposes as required, at any time and location, without prior consent from the entrants or compensation, while ensuring proper crediting of the authors' names.
- 18.7 To ensure fairness, members of the jury committee, employees of the Macao Government Tourism Office, and their immediate family members are inelible to participate in this contest. The photos will be publicly exhibited after being evaluated by the jury committee.
- 18.8 Awarded authors must submit original high-resolution digital files of their works for the organizer's use in printing exhibits, publications, or promotional materials.
- 18.9 The organizer reserves the right to cancel or terminate the contest, interpret, and amend all the terms and conditions outlined in this contest's guidelines and entry form. Contest results are final and not subject to dispute by the entrants.
- 18.10 If any unresolved issues arise within these contest guidelines, the organizer reserves the exclusive authority to modify and interpret such provisions at its sole discretion.
- 18.11 In case of any discrepancies among the Chinese, Portuguese, and English versions of these guidelines, the Chinese version shall prevail.
- 18.12 The organizer reserves the right to make final interpretations and decisions regarding any disputes arising from this contest.
